It is understood that no other photographer, amateur or professional, shall be allowed to photograph at the wedding while the photographer _____ is working (unless agreed upon) and that breach of this agreement will constitute a reason for non-completion of the job with no liability to the photographer _____ and loss of initial deposit by the signing party.

4. Upon signature, the photographer _____ reserves the time and date agreed upon, and will not make any other reservations for that same time and date. For the reason, all deposits are non-refundable, even if the date is changed or the wedding is cancelled for any reason.

A 50% deposit is required upon the signing of this contract, and the remainder is to be paid upon completion of the photography/Wedding day.
